

The Clean Cap system protects the end of the pole sections from accidental damage due to misplaced alignment and cleans out the inner female joint every time you unship. Also will stop your sections sinking if dropped into the water.

Super toughened epoxy resin. Developed by Reglass. Following the success of Sun Core, we have modified the molecular structure of Sun Core and enhanced the mechanical performance of the pre-preg. The Super toughened epoxy resin formulation gives an extremely elegant and innovative black colour finish.





Fusion is two high modulus carbons fused together as one whilst wrapped on the mandrel. The end result being ultra rigid top kits with no tip bounce, allowing the angler to hit lightning fast bites with ease.

The ultimate pre-preg concept. This new resin strongly bonds the carbon fibres & provides the ultimate fishing action.





A special resin finish that enables the pole to be shipped incredibly smoothly & quickly. It's applied from sections 5 to the 13m butt section on many of our poles.

A fine wrap of pure teflon bonded directly onto the male joints, substantially reducing carbon to carbon wear. A simple twist locks the sections in place. We are the only manufacturer in the world that has this innovative feature.





A carbon and resin treatment providing an anti-friction finish that enables the pole to be shipped with incredible ease during wet or dry conditions. This revolutionary surface not only adds strength, but also protects the overall fishing action during hot and cold temperatures.

The first ever formulation of its kind. Exclusive to Reglass production. Nanolith provides unique characteristics of vibration, damping & high strength. The Nanolith is an exceptional molecule, it's a thousand times smaller than a single carbon wire, and creates a bond at atomic level between fibre and matrix.





This clever technology provides the angler with a silky smooth elastic system. A series of teflon coated inner steps prevents the elastic from making contact with the inner wall of the pole sections.

The new Reglass patent HPS is a super special technology which is giving a 45° angle on the final parts of sections 6-7-8 and it permits a superlative and optimal scrolling of the pole through our hands without any brake and pain! This is technically avoiding the troublesome step which is producing problems and only now and in future will increase the easy handle during the scroll and the slide of our poles.

**SLOT SYSTEM:** Really a new system that is actioning during the fighting moment: this system is permitting us to pull the elastic in the stronger and faster way in order to have a quicker landing of the fish, even if is a real big one.

**AB TIP:** Ab tip system is permitting to the last kit part to become stronger ,stiffer and faster. The tip hole is even bigger in order to use hollow elastic and cones. In this way tip and section B are melted inside a unique spare!

So this is an high frequency fiber able to stop a lot of vibrations and to block the mini-movements of our poles.

The SIGNATURE M TOPSET SERIES developes itself starting from same mandrels used for the MV-R S range and like these ones these are sold ready to use (already cut on the top and fit with ptfe bushes).







#### 1) Definitions

If the amendments or supplements to the General Sales Conditions are not accepted in writing by the Buyer within 15 days of the date of the notice, the Seller may terminate any contractual relationship in place with the Buyer, in which case the latter may not claim any damage or compensation.

#### 12) The Seller's trademarks and distinctive signs

14) Applicable Law - Competent Authority For each Sale Agreement entered into between the Buyer and the Seller, all matters not expressly governed by these General Sales Conditions will be governed by Italian law. In the event of an international sales relationship, for all matters not governed by these General Sales Conditions, the Vienna Convention of 1980 will apply and for all matters not governed by the latter, the Italian Civil Code will apply. Any dispute arising between the Parties regarding the interpretation, validity, or performance of each Sale Agreement governed by these General Sales Conditions will be submitted to the exclusive jurisdiction of the Court of Bologna, subject to the jurisdiction of the Business Division of the Court of Bologna for the matters within the remit thereof.
